In consideration of engaging in training of my dog and on behalf of myself, and our personal representatives, heirs, next-of-kin, spouses and assigns, I HEREBY:

1. Acknowledge that training such as that which Owner's dog shall engage in is AN INHERENTLY DANGEROUS ACTIVITY AND INVOLVES RISKS THAT MAY CAUSE SERIOUS INJURY OR DEATH.

2. Voluntarily assume the risk and danger of injury or death inherent in the training of the dog.

3. RELEASE, DISCHARGE AND PROMISE NOT TO SUE the Trainer, doing business under her own name or any other name and/or any of its owners, officers, employees and agents for any loss, liability, damages, or cost whatsoever arising out of or related to any loss, damage, or injury (including death) to the Owner's dog and property.

4. Release the Trainer from any claim that such the Trainer are or may be negligent in connection the training of the dog.

5. INDEMNIFY, AND SAVE AND HOLD HARMLESS the Trainer, instructors, its employees and agents from and against any loss, liability, damage or cost they may incur arising out of or in any way connected with the training of the dog and any equipment of gear provided therewith or any acts or omissions of Trainer or other employees or agents.

6. The Undersigned expressly agrees that the foregoing release and waiver of liability, assumption of risk, and indemnity agreement is governed by the State of Florida and is intended to be as broad and inclusive as is permitted by Florida Law and that in the event any portion of this Agreement is determined to be invalid, illegal, or unenforceable, the validity, legality and enforceability of the balance of the Agreement shall not be affected or impaired in any way and shall continue in full legal force and effect.

7. Acknowledge that this document is a contract and agree that if a lawsuit is filed against the Trainer or its owner, agents or employees, for any injury or damage in breach of this contract, the Owner will pay all attorney's fees and costs incurred by the Trainer in defending such an action.

I have read this entire Release of Liability Document. I understand it is a promise not to sue and to release the stable, It's owners, employees and agents for all claims. I have made a free and deliberate choice to sign this Release and Waiver as a condition to engaging in the training of my dog.
