### **Grooming, Daycare and Boarding Waiver**

I, the undersigned, hereby acknowledge and agree that all the information provided in this Application is complete and accurate to the best of my knowledge. I further acknowledge and agree I have read, understand, and agree to all terms and conditions contained in the Daycare, Boarding and Grooming Policies, Procedures, and Release, Waiver of Liability, Assumption of Risk, and Indemnification Agreement (the "Agreement"), as they may be amended from time to time, which are attached and fully incorporated into this application by reference. I hereby execute the Agreement for my pet, myself and my heirs, successors, representative and assigns. I further attest that if I am not the sole owner or representative of the pet subject to this application that my signature is sufficient to enter into this Agreement for and on behalf of any other owner or representative:

1. Owners understand and agree to entrust their pet to Sonny's Place for Daycare/Boarding, or, Grooming and that during normal play and grooming, Owner's pet may sustain injuries. All pets are monitored by staff to avoid injury, but scratches, punctures, torn ligaments, and other injuries may occur despite the best supervision. Cats will be housed in their own condo; they will be permitted time in the Cat Boarding Room out of the condo with siblings but no other Cats.
2. I am aware that if my pet is groomed and their coat is matted, I have the following options: Owner can take the pet home and address matting and schedule a grooming appointment for a later date. Groomers and staff will de-mat my pet at a rate set by the Grooming staff, this will be in addition to the base grooming fee, care will be made to ensure the pet doesn't become overly stressed. Groomers can shave down the pet to address severe matting that cannot be brushed without causing stress and injury to the pet, there could be additional fees in addition to the base grooming fee. In the event a pet cannot be groomed safely without danger to the staff or others, Sonny's Place will use muzzles, e-collars, slings, straps, etc. Grooming services may be stopped mid-groom if necessary, for the safety of the Pet or groomer. Grooming fees may still be applied.
3. I agree that Sonny's Place shall not be responsible or liable for any lost, stolen, or damaged personal property belonging either to my Pet or me.
4. All pets must pass a general behavior assessment to attend daycare or boarding. No pet may be admitted that shows any signs of any type of aggression. Owner understands that daycare is intended for dogs that are well socialized with other dogs and enjoy off-leash group play. Daycare is NOT a means to socialize dogs or build communication skills and confidence, in dogs that do not enjoy playing with other dogs. Owner further understands and agrees that in admitting Owner's pet(s) to Daycare/Boarding, Owner is representing to Sonny's Place that Owner's pet(s) is/are in good health and have not harmed, shown aggression, or exhibited any threatening behavior towards any person or other like animal. Any pet demonstrating aggression or other behavior deemed unacceptable by Sonny's Place, pet(s) may be required to leave Daycare/Boarding.
5. Owner further understands and agrees that Sonny's Place owners and staff, or volunteers, will not be liable for any illness, injury, death, and/or escape of Owner's pets(s) provided that reasonable care and precautions are followed, and Owner hereby releases all of them of any liability of any kind whatsoever arising from or because of Owner's pets(s) attending or participation in all services offered.
6. Owner further understands and agrees that any behavioral or physical health problems that develop with the Owner's pet(s) while at Sonny's Place will be handled and treated as deemed best by the staff, in their sole discretion, and Owner expressly agrees to assume full financial responsibility for all expenses arising or relating thereto. This includes aggressive or destructive behavior.
7. Owner further understands and agrees that the Owner's pets(s) are healthy and will always while staying at Sonny's Place have current vaccinations. Owner is not enrolling any pet at Sonny's Place that has any conditions that could potentially jeopardize the health of other pets or people and has not had any potentially communicable condition within 30 days prior to enrollment.
8. Owner further understands that even if Owner's dog(s) are vaccinated for Bordetella (Canine Cough) or Canine Influenza, there is a chance that the Owner's dog(s) can still contract Canine Cough or Influenza. Owner understands that Owner's dog(s) may be exposed to intestinal parasites while at Sonny's Place. Staff will clean

up feces immediately, but recommends Owner test their dog(s) stool every 6 months. Owner further understands that there is a chance that the Owner's dog(s) may be exposed to puppy warts. I agree that I will NOT hold Sonny's Place responsible if Owner's dog(s) contracts Canine Cough, Canine Influenza, intestinal parasites, or puppy warts.

9. Owner further understands and agrees that Owner's pet(s) nails must be kept short while at Sonny's Place. This will keep scratches due to long nails to a minimum. Owner gives staff permission to clip Owner's pet(s) nails without notice if they deem it necessary. The cost is as posted and will be added to Owner's bill due at time of pick up.
10. Owner understands and agrees that Owner's dog(s) will be placed in crates during nap times or back into the Daycare if boarding and joining in daycare for the day.
11. Owner understands that pre-paid packages are nonrefundable and expire 30 days after purchase. Pre-Paid packages can only be used for Daycare expenses, they cannot be used to pay for Boarding or Grooming services. Fees are due and payable at the end of each day. Payment may be made by cash, check, or credit card. Discounted packages are provided only if they are paid for in advance. Owner further understands that due to the small size of the Daycare, reservations are not required, however, we cannot guarantee space will be available for walk-in customers.
12. Daycare reserves the right to refuse admittance to any pet that does not meet the health, temperament or other facility standards. The determination shall be made at the sole discretion of Sonny's Place.
13. I agree to allow Sonny's Place to obtain medical treatment for my pet, if, in its sole discretion it appears that he/she is ill, injured or exhibits any other behavior that would reasonably suggest that my Pet may need medical treatment. I agree that I am fully responsible for the cost of any such medical treatment, and for the cost of any transportation for the purposes of such treatment, provided to my pet.
14. I understand that if I abandon my Pet at Sonny's Place, Sonny's Place will, by default, become the legal owner and guardian of the Pet. Sonny's Place will, in its sole discretion, determine whether to try to rehome and adopt the Pet from the Sonny's Place location at which he/she was abandoned or will relinquish the Pet to an unrelated shelter of its choice.

I hereby agree to expressly and forever generally waive, discharge claims, indemnify, release from liability, save, hold harmless, and defend Sonny's Place, their invitees, sponsors, advertisers, owners, officers, directors, employees, volunteers, agents, representatives, leasers, and all others having interest in Sonny's Place from and against any and all injury, liability, claims, litigation, actions, suits, costs, losses, damages, attorney's fees, expenses or demands of every character whatsoever on the account of, arising out of, resulting from or relating in any way to (I) any act or omission of the releasees, including negligence, and (ii) my or my pet's participation in services offered. I agree that this release shall be binding on me and my successors, heirs, legal representatives, and assigns. I also expressly and forever release Sonny's Place from any duty to protect me or my pet(s) from injury of any kind and agree that even if Sonny's Place chooses to implement safety precautions, such actions shall not alter the fact that I have released Sonny's Place from any duty to protect me or my pet(s). I have read and fully understand the terms of this pet release, waiver of liability, assumption of risk and indemnity agreement and understand that I have given up substantial rights by signing it and have signed freely and voluntarily without any inducement, assurance or guarantee and intend it to be a complete and unconditional release of liability to the greatest extent permitted by the law and agree that if any portion of this agreement is held to be invalid or unenforceable, the remainder of this agreement shall remain in full force and effect. I agree that it is intended that all terms of this agreement control despite any statute or law that would otherwise protect me or my pet(s).
