

Boarding/Daycare Waiver and Consent Form

First and foremost, the safety and well-being of you, your pet(s), and our staff is of the highest importance. Ensuring that everyone remains safe is our priority! This release is required to participate in any activity offered by Miss Kate's Bed and Biscuit.

Please read each statement carefully and acknowledge the following by writing your initials on the line provided.

_____ - I have disclosed all known risks, dangers, and medical conditions on the registration form and represent that my pet(s) is/are in good health, current on all required vaccinations, free of fleas, ticks, lice and has not been ill within the last 30 days.

_____ - I understand that there are inherent risks associated with participating in boarding, daycare, one-on-one/group play to include: exposure to parasites, viruses, other medical conditions passed from dog/dog or dog/person; sprains, strains, bites, nicks, cuts, broken bones, fatigue, dehydration, or death. I further understand that every potential risk cannot be listed, nonetheless I agree that the benefits outweigh the risks.

_____ - I understand that I am solely liable for medical care expenses and damages that result from injuries caused by my pet and that I will resolve the matter directly with the owner of the other pet(s).

_____ - I understand that Miss Kate's Bed and Biscuit has the right to refuse or send home any pet(s) they feel will pose a hazard to the safety and wellbeing of other pets and/or the staff. We do not accept pets that have been coughing within the last 7 days, pets with open wounds, pets with contagious diseases, or pets that are aggressive towards people.

_____ - I understand that Miss Kate's Bed and Biscuit reserves the right to remove my pet(s) from a play or boarding area and place in a separate holding area should my pet(s) display any unwanted behaviors. I also understand that my pet(s) may be permanently removed from boarding and daycare facilities at any time.

_____ - I understand that if my pet(s) becomes ill or injured, Miss Kate's Bed and Biscuit will make a reasonable attempt to contact me. Should they be unable to reach me or my listed emergency contact as to the care to be administered, I agree to permit them to use UF Pet Emergency Treatment Services, Ocala. In an emergency it may not be feasible to contact me prior to seeking medical care and incurring an expense.

_____ - Overnight Boarders may check-in/drop-off anytime between 7am and 6pm 7-days a week. Pick-up/check-out time is 2pm the last day of boarding. Pick-up after 2pm will incur a \$15 fee.

_____ - Boarding deposit and cancellation policy: A 50% deposit of the total cost is required on all boarding reservations upon booking (during holidays and weekends). Cancellations must be made 48 hours prior to check in to receive a refund. Deposit will not be refunded if cancelling within 48 hours of scheduled appointment. No Shows will be required to pay upfront the full amount of all boarding fees prior to a future reservation being accepted.

_____ - Prices and services are subject to change without prior notification.

_____ - **MEDICAL AUTHORIZATION:** Should my pet(s) become ill or injured, I authorize Miss Kate's Bed and Biscuit to take actions they deem as necessary to ensure the health, well-being, and safety of my pet(s). I agree to assume full financial responsibility for all expenses incurred as a result of their actions.

_____ - **AUTHORIZATION TO PLAY:** I affirm that I am not aware of any vicious tendencies. I represent that my pet(s) are social and have not harmed or shown threatening behaviors towards any person or other pet(s). I understand that although Miss Kate's staff will monitor playtime, incidents or injuries may occur. I hereby authorize Miss Kate's Bed and Biscuit to allow my pet(s) to participate in group play.

_____ - **PHOTOGRAPHS, VIDEOS AND STATEMENTS:** I authorize Miss Kate's Bed and Biscuit to use my pet(s) visual image(s) and statements in newsletters, posters, social media and/or other materials.

_____ - I hereby voluntarily release, forever discharge, and agree to hold harmless and indemnify Miss Kate's Bed and Biscuit and its agents, successors, heirs, from all liability, claims, demands, actions, or rights of action, which are related to, arise out of, or are in any way connected to my pet's participation in activities at Miss Kate's Bed and Biscuit, including those allegedly attributable to the negligent acts or omissions of Miss Kate's Bed and Biscuit or their staff.
