<p>Liability</p> <p>I understand certain "activities" that my dog may participate in, including walks, field trips, playgroups, daycare, boarding, one-on-one play, movement within and outside the facility, and transportation to and from Trey Clark's Dog House involve risk and possible injury, including but not limited to:</p> <p>Exposure to parasites, viruses, and other medical conditions passed from dog-to-dog or person-to-dog; sprains, strains, bites, broken bones; motor vehicle accident during transportation; and fatigue, dehydration, nicks, cuts, or death.</p> <p>I further understand that each and every potential risk cannot be listed above but, nonetheless agree that the benefits associated with dog socialization outweigh the possible risks, therefore, I hereby voluntarily release, forever discharge, and agree to hold harmless and indemnify Trey Clark's Dog House and its agents, successors, heirs, from any and all liability, claims, demands, actions, or rights of action, which are related to, arise out of, or are in any way connected with my dog's participation in activities at Trey Clark's Dog House, including those allegedly attributable to the negligent acts or omissions of Trey Clark's Dog House their staff.</p> <p>Further, I understand that I may be exposed to certain risks when bringing my dog to participate in activities at Trey Clark's Dog House or when picking up my dog from participating in activities at Trey Clark's Dog House. Such risks may include property damage and/or physical injury inside or outside the facility, such as from falling, slipping, illness, and/ or dog bites. Therefore, I hereby voluntarily release, forever discharge, and agree to hold harmless and indemnify Trey Clark's Dog House, its agents, successors, heirs from any and all liability, claims, demands, actions, or rights of action, which are related to, arise out of, or are in any way connected with my dog's participation in activities at Trey Clark's Dog House, including those allegedly attributable to the negligent acts or omissions of Trey Clark's Dog House or their staff.</p>

However, if Trey Clark's Dog House is unable to reach me, I consent to Trey Clark's Dog House seeking appropriate veterinary care and I accept responsibility for any and all associated expenses. Trey Clark's Dog House will not pay any portion of veterinary expenses associated with seeking medical care for my dog if so necessary.</p>	
<p>Photographs and Statements</p> <p>I authorize use of my dog's visual image(s) and statements in newsletters, posters, and other materials.</p>	
<p>Agreement to Pay</p> <p>Trey Clark's Dog House accepts check, cash, or online payments such as Venmo, Zelle, and PayPal. I agree to pay the service rates in effect for my dog's participation in activities at or with Trey Clark's Dog House. I further agree to pay for any additional services requested such as grooming, drop-off, and/or pick-up service.</p>	
<p>Dog Abandonment</p> <p>Trey Clark's Dog House will make every effort to contact dog owners who do not return to pick up their dog. After 15 days of failed attempts to contact said dog owner, Trey Clark's Dog House will relinquish the dog to the Houston SPCA.</p>	
<p>Evaluation of Dog Prior to Participation</p> <p>Every dog must be evaluated by Trey Clark's Dog House prior to participating in any activity. Such evaluation can only assess the behavior at the time of evaluation. The evaluation may assess the dog's temperament and interactions with other dogs and Trey Clark's Dog House staff.</p>	
<p>Right to Decline</p> <p>I understand that Trey Clark's Dog House reserves the exclusive right to decline participation or to terminate participation in activities at Trey Clark's Dog House to any dog at any time for any reason.</p>	
<p>Attorney Fees, Applicable Law & Venue</p> <p>Should Trey Clark's Dog House, or anyone acting on their behalf, be required for any reason to incur attorney fees and costs to enforce or defend this agreement, I agree to indemnify and reimburse Trey Clark's Dog House for such fees and costs. Further, I agree and understand that any disputes arising out of this Agreement will be decided pursuant to the laws of the State of Texas and venue shall be in Harris County.</p>	
<p>Valid Dates</p> <p>These agreements, waivers, and authorizations will remain valid and in force as long as and whenever my dog participates in any activity at or with Trey Clark's Dog House.</p>	
<p>Warning</p> <p>By signing this document, I acknowledge that if my dog is, or I am hurt during my dog's participation activities at Trey Clark's Dog House, I may be found, by a court of law, to have waived my right to maintain a lawsuit against Trey Clark's Dog House on the basis of any claim from which I have released them herein.
